In response to your correspondence dated July 19, 2022; the Canada Border Services Agency (CBSA) - International Events and Convention Services Program (IECSP) officially recognizes the following event:

2022 North American Youth Chess Championship August 10 - 14, 2022 Sheraton Cavalier Hotel Calgary, Alberta

The information provided to the CBSA states there will be approximately 300 competitors to which 40% are foreign to Canada as well as 500 attendees to which 25% are foreign to Canada. The event is closed to the general public with sales.

Goods imported for sale are not eligible under tariff No. 9993.00.00.00. These goods must be accounted for at time of release on a <u>Form B3</u>, *Canada Customs Coding Form*. Commercial release processing is fully explained in Customs Memorandum <u>D17-1-5</u>.

Under certain circumstances, the CBSA will require a security deposit on goods temporarily imported to Canada. These goods are normally documented on the Temporary Admission Permit (Form E29B).

At the time of exportation, goods granted temporary admission on a Form E29B or Carnet must be presented along with importer's/owner's copies of the appropriate documentation to CBSA for verification and certification. This presentation may occur at a CBSA office inland or at the port of export, depending on the circumstances involved and is necessary for you to receive a refund of any securities posted. Please note that the refund is not immediate.

To limit the further spread of coronavirus in Canada, new travel restrictions are in place across all border crossings. Please review the following link carefully to determine if you are eligible to enter Canada: https://travel.gc.ca/travel-covid

CBSA requires everyone seeking admission into Canada to properly declare themselves to CBSA by providing accurate identification. CBSA will accept a valid passport as proof of citizenship.
